

NEWS AND EVENTS OF GRGSMS FOR THE MONTH OF FEBRUARY 2021

- 1. Urjith, the annual mega Management Meet of GRGSMS, was held virtually during 1-3 February 2021. There were over 560 eligible registrations and 400 student participants from 70 prestigious institutions including IIM Bangalore and other institutions from all over India for Urjith this year. Mr K A Ajayan, Managing Partner, VRDDHI Consulting & Training Services, Past President, Calicut Management Association, was the Chief Guest for the Inaugural session and the session was live streamed through Facebook, YouTube and the institution's website on 1st February 2021. As a part of the event, the prestigious Chandrakanthi Memorial Young Business Leader Contest and Digi Peddle Contest was conducted virtually for PG students through GoToMeeting platform on 1st February 2021. During the valediction of the event, two teams were announced as winners. The team with highest turnover was 'Casablanca' with a total turnover of

Rs 77,106. The team with highest visibility and reach was 'Eco Shop' with a total of 97 transactions.
