It may please be noted that consequent to judgement of Hon'ble Supreme Court delivered on 31.10/2002 in TMA Pai Case, the AICTE had issued interim policy regulations, which has been notified in the Gazette of India on 26.05/2003. All the provisions contained in the interim policy regulations shall be applicable for the academic year 2003-2004 in respect of all the AICTE approved institutions.

I am directed to state that on consideration of the observations and recommendations of the Expert Committee of the All India Board of Management Studies which visited the college on 25th May, 1993 and further recommendations made by the Chairperson, All India Board of Management Studies, the All India Council for Technical Education has accorded approval to GRG PSGR Krishnammal College for women, Coimbatore for the conduct of the MBA programme with an annual intake of 40 (forty) students from the academic year 1993-94 subject to the fulfilment of the following conditions which have been agreed to be fulfilled by the Founder and Correspondent of the GR Govindarajulu School of Management Studies for women in PSGR Krishnammal College for women, Coimbatore and also subject to the Assurance given by the State Govt. of Tamilnadu as also indicated below:-

6. The intake of students in the MBA Programme will not be altered without the prior approval of the AICTE.
7. The teaching faculty should be given pay-scales as per the UGC/AICTE guidelines prescribed from time to time.
8. The admissions should be made as per norms and guidelines of the AICTE as adopted by the State Government of Tamilnadu.
9. The admissions to the Courses should be made only after the minimum requisite/prescribed facilities including the faculty/teaching staff are created/provided and the affiliating University has given permission to start the course.
10. The Faculty/teaching staff should be recruited on All-India basis by open selection as per procedure, qualifications and experience etc. prescribed by the AICTE from time to time. State based selections would be permissible for such posts for which the State Government prescribes "State-based Selection" as a general policy.
11. That tuition and other fees will be charged as prescribed by the State Govt. within the overall criteria prescribed by the AICTE from time to time.
12. No Capitation fee or donation shall be charged from the Students/guardians of the students in any form.
13. A separate account shall be maintained for the MBA programme and the same shall be audited annually by a Chartered Accountant and be open for inspection by the AICTE or Board or person authorised by it.
14. The teaching and other staff should be selected according to procedures, qualifications and experience(s) prescribed by the AICTE from time to time.
